What is an *Initial Case Review* ?

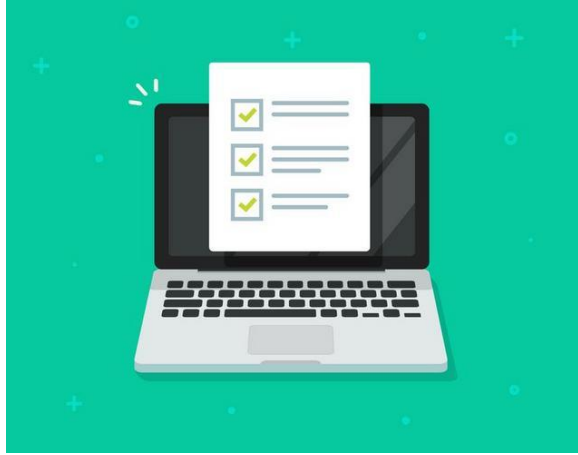
How Should I Prepare For An Initial Case Review?

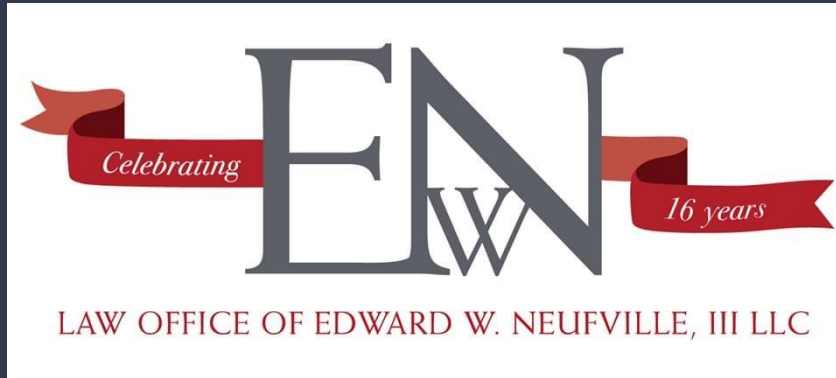
